The Milwaukee County Community Business Development Partners is pleased to announce that your firm has been certified as a Airport Concessionaire Disadvantaged Business Enterprise (ACDBE) in Wisconsin, under a Unified Certification Program (UCP) in accordance with 49 CFR, Part 23.

ACDBE certification is continuing from the date of this letter, but is contingent upon the firm renewing its eligibility annually through this office. You will be notified in advance of your obligation to continue eligibility in a timely fashion. Failure to continue your eligibility will result in immediate action to decertify the firm.

ACDBE certification is NOT a guarantee of work, but enables the firm to compete for, and perform, contract work on all USDOT Federal Aid (FAA) projects in Wisconsin as a ACDBE contractor, sub-contractor, consultant, and sub-consultant or material supplier.

If, at any time, there is a material change in the firm, including, but not limited to, ownership, officers, Directors, scope of work being performed, daily operations, affiliations with other businesses or individuals or physical location of the firm, you must notify this office in writing within 30-days of the change. Notification should include supporting documentation. You will receive timely instruction from this office as to how you should proceed, if necessary.

Your firm may compete for, and perform, work on all USDOT Federal Aid (FAA) projects throughout Wisconsin, receiving ACDBE credit for work performed in the following areas:
